Application Process:

- Complete Membership Application form and return to the Howick Club reception Information required to complete the form:
 Photo of applicant (passport size) – This can be taken at reception.
 Signatures of two current members who will, propose and second the application
- 2) Payable with the application is a \$10.00 nomination fee
- 3) Applications are approved at the clubs monthly Executive Meeting, held on the last Thursday of each month (with the exception of December meeting which is held a week earlier) Completed applications are required to be lodged by the Tuesday prior to the meeting
- 4) Once the application has been approved at an Executive Meeting, the applicant's photo will be displayed on the clubs notice board for two weeks
- 5) New members will be posted an invitation to attend a Club Introduction Day
- Once application has been approved new members will be sent an email requesting payment of the Joining Fee and Annual Subscription (or part thereof).
 On payment you will receive your membership card
- 7) **Note:** The Howick Club's Subscription year is from: 1st July to 30th June Annually Also note that annual subscription invoices are emailed out to members.
- 8) **Note:** If your partner intends to be a social member, make sure the **Full Membership**, is the person who will use the facilities the most, as it is not possible to transfer memberships.
- 9) Your Membership should be kept current. If a membership lapses all outstanding subscription must be paid before a membership is reinstated.
