Application Process:

- 1) Complete the membership application form and return to the Howick Club reception.
Information required to complete the form:
Provide a current photo of the applicant (taken within last 2 years, passport size)
If you do not have a photo, we can take one at reception.
Provide first nominator and seconder Howick Club membership numbers, name and signature along with the years they have known the applicant.
*First nominator must be an existing Ordinary (Full) or Life member.
*Seconder must be an existing Ordinary (Full), Life or Social member.
- 2) Payable with the application is a \$20.00 nomination fee. This must be done at the time the application is submitted.
- 3) Applications are approved at the club's monthly Executive Meeting, held last Thursday of each month (except for the May & December meetings which are held earlier)
- 4) Once the application has been approved at an Executive Meeting, the applicant's photo will be displayed on the club's noticeboard for two weeks.
- 5) Once application has been approved new members will be sent an email requesting payment of the Joining Fee and Annual Subscription (or part thereof) and an invitation to attend a Club Introduction Day.
On payment the applicant will receive their membership card.
- 6) **Note:** The Howick Club's Subscription year is from: 1st July to 30th June (annually)
Also note that annual subscription invoices are emailed out to members.
- 7) **Note:** If your partner intends to be a social member, make sure the **Full Membership**, is the person who will use the facilities the most, as it is not possible to transfer memberships.
- 8) Your Membership should be kept current. If a membership lapses all outstanding subscription must be paid before membership is reinstated.
Any Social or Youth Member linked to Full Membership will also be considered inactive until the Full Membership is reinstated.
- 9) If a Full Member is age 65 and has been a member for 5 consecutive years then the Full Member will be eligible to become a Super Member at the next annual subscription time.
