## ***Criteria for Social Membership***

- 1) Must be the legally married spouse or common law spouse of an existing ordinary or life member in accordance with the Howick Club rules. If the Social Member is no longer the partner or common law Spouse, the Social Membership will become void.
- 2) A Social Member's rights are restricted by the following:
  - (I) No right to vote or attend any General Meeting
  - (II) No right to hold office or be a member of the Executive Committee
  - (III) No right to represent the club in competitions.
  - (IV) Cannot nominate and or second anyone for membership
- 3) Social Memberships are not part of the Lucky Membership Draws.
- 4) A Social Membership becomes void if the Full Member is no longer a Financial Member.
- 5) A Social Membership can be revoked by the Full Member at any stage.

## ***Application Process:***

- 1) Complete Social Membership Application form and return to the Howick Club reception  
Information required to complete the form:  
Photo of applicant (passport size) – This can be taken at reception.  
Signature from your partner who nominates you
- 2) Payable with the application is a \$20.00 nomination fee
- 3) Applications are approved at the club's monthly Executive Meeting, which are held on the last Thursday of each month (with the exception of December meeting which is held a week earlier).  
We recommend completed applications be lodge by the 7<sup>th</sup> of the month but will be accepted Up to 2 weeks prior to the last Thursday of the month.
- 4) Once the application has been approved at an Executive Meeting, the applicant's photo Will be displayed on the club's notice board for two weeks
- 5) Once the application has been approved new social members will be sent an email requesting payment of Annual Subscription (or part thereof).
