Criteria for Youth Membership:

- 1) Must be the child (aged 18-24) of an existing Ordinary (Full) or Life member in accordance with the Howick Club rules.
- 2) A Youth Member's rights are restricted by the following:
 - (I) No right to vote or attend any General Meeting
 - (II) No right to hold office or be a member of the Executive Committee
 - (III) No right to represent the club in competitions.
 - (IV) Cannot nominate and or second anyone for membership
- 3) Youth Memberships are not part of the Lucky Membership Draws.
- 4) Youth Membership becomes void if the Ordinary (Full)/Life Members are no longer a Financial Member.
- 5) Youth Membership can be revoked by the Ordinary (Full)/Life Member at any stage.

Application Process:

- Complete the membership application form and return to the Howick Club reception.
 Information required to complete the form:
 Provide a current photo of the applicant (taken with in last 2 years, passport size)
 If you do not have a photo, we can take one at reception.
 - Name/signature and membership number from your parent who nominates you.
- 2) Payable with the application is a \$20.00 nomination fee. This must be done at the time the application is submitted.
- 3) Applications are approved at the club's monthly Executive Meeting, held last Thursday of each month (except for the May & December meetings which are held earlier)
- 4) Once the application has been approved at an Executive Meeting, the applicant's photo will be displayed on the club's noticeboard for two weeks.
- Once the application has been approved new Youth Members will be sent an email requesting payment of Annual Subscription (or part thereof).
 On payment you will receive your membership card.
- 7) **Note:** The Howick Club's Subscription year is from: 1st July to 30th June (annually) Also note that annual subscription invoices are emailed out to members.
